Preliminary

1. Defined terms

1.1 In this Constitution unless the contrary intention appears:

ACNC Act means the *Australian Charities and Not for profits Commission Act 2012* (Cth), or any other legislation relating to the establishment or operation of an Australian charities commission and/or a national regulatory framework and/or a national education body or otherwise for the not for profit sector, as modified or amended from time to time and includes any regulations made under that Act or any other such legislation and any rulings or requirements of the Commissioner of the Australian Charities and Not for profits Commission under that Act, or any commissioner or body under any other such legislation, having application to the Company.

Adoption Date means the date of adoption by the Company of this Constitution containing the Ordinary Member and Director and Teacher Member classes of membership.

Alternate Director means a person appointed as an alternate director under clause 42.

Applicable Not for Profit Laws means any law relating to the regulation of charities or not for profit entities applicable to the Company, including the *ACNC Act*, *the Charities Act*, each *Charitable Fundraising Act*, the *Tax Act*, section 150 of the *Corporations Act* and any guidelines or requirements of any commissioner or body under any such law, having application to the Company.

Auditor means the Company's auditor.

Board means all or some of the Directors acting as a board.

Charitable Fundraising Act means the legislation of any State or Territory of Australia, or the Commonwealth of Australia, regulating the raising of funds for charitable purposes and applicable to the Company, which may include, relevantly, *Charitable Fundraising Act 1991* (NSW).

Charities Act means the *Charities Act 2013* (Cth).

Company means Central Coast Conservatorium of Music ACN 675 954 720.

Constitution means the constitution of the Company as amended from time to time.

Corporations Act means the *Corporations Act 2001* (Cth) as modified or amended from time to time and includes any regulations made under that Act and any exemption or modification to that Act applying to the Company.

Director includes any person occupying the position of director of the Company and, where appropriate, includes an Alternate Director.

Director and Teacher Member means a person admitted as a Member that meets the eligibility criteria in clause 8.6.

Gift Fund means a gift fund called the DGR Account, established under clause 6 in accordance with the requirements of the Tax Act.

Imported Provisions means the following provisions of the Corporations Act:

- (a) section 139 (*Company must send copy of constitution to member*);
- (b) sections 191 to 194 (*disclosure of, and voting on matters involving, material personal interests*);
- (c) Divisions 1 to 7 of Part 2G.2 (*meetings of members of companies*); and
- (d) Part 2G.3 (*minutes and members' access to minutes*).

Member means a member under clause 8 (and in clauses 16, 17, 19 and 22, Member includes a Member present in person or by proxy, attorney or Representative).

Objects means the Company's objects set out in clause 4.

Ordinary Member means a person, corporation or organisation admitted as an Ordinary Member in accordance with clause 8.15.

Register means the register of Members of the Company.

Registered Entity means a body corporate registered under the *ACNC Act*.

Representative means a person appointed by a Member to act as its representative under clause 28.

Seal means the Company's common seal (if any).

Secretary means any person appointed by the Board to perform any of the duties of a secretary of the Company and if there are joint secretaries, any one or more of those joint secretaries.

Tax Act means the *Income Tax Assessment Act 1936* (Cth) and the *Income Tax Assessment Act 1997* (Cth) as modified or amended from time to time and includes any regulations made under that Act and any rulings or requirements of the Commissioner of Taxation of the Commonwealth of Australia having application to the Company.

Teacher means a person engaged by the Company to provide teaching services.

- 1.2 In this Constitution, except where the context otherwise requires, an expression in a clause of this Constitution has the same meaning as in the Corporations Act. Where the expression has more than one meaning in the Corporations Act and a provision of the Corporations Act deals with the same matter as a clause of this Constitution, that expression has the same meaning as in that provision.

2. Interpretation

- 2.1 In this Constitution, except where the context otherwise requires:
- (a) the singular includes the plural and vice versa, and a gender includes other genders;
 - (b) another grammatical form of a defined word or expression has a corresponding meaning;
 - (c) a reference to a clause, paragraph, schedule or annexure is to a clause or paragraph of, or schedule or annexure to, this Constitution, and a reference to this Constitution includes any schedule or annexure;
 - (d) a reference to a document or instrument includes the document or instrument as novated, altered, supplemented or replaced from time to time;
 - (e) a reference to a statute, ordinance, code or other law includes regulations and other instruments under it and consolidations, amendments, re-enactments or replacements of any of them;
 - (f) a reference to **A\$, \$A, dollar** or **\$** is to Australian currency;
 - (g) the meaning of general words is not limited by specific examples introduced by including, **for example** or similar expressions; and
 - (h) a reference to **applicable law** includes the applicable law and any applicable authorisation or licence granted thereunder.
- 2.2 Headings are for ease of reference only and do not affect interpretation.

3. Application of the Corporations Act and Replaceable rules

- 3.1 If, while the Company is a Registered Entity, the Corporations Act operates such that an Imported Provision does not apply to the Company because the Company is a Registered Entity:
- (a) a clause in the same terms as the Imported Provision, along with any relevant definitions in the Corporations Act, is deemed to be included in this Constitution and to apply to the Company to the extent the Imported Provision would have applied to the Company were the Company not a Registered Entity (**Equivalent Clause**); and
 - (b) a reference in this Constitution to an Imported Provision is deemed to be a reference to the Equivalent Clause.

- 3.2 To the extent permitted by law, the replaceable rules in the Corporations Act do not apply to the Company.

Purpose and powers of the Company

4. Objects

- 4.1 The objects for which the Company is established are to:
- (a) promote and encourage the appreciation of music in all its forms, especially among the young within the Central Coast region of New South Wales and beyond;
 - (b) provide means and opportunity to all students of music on the Central Coast for the achievement of competence and excellence according to their talent in the various branches of music and study, both practical and theoretical;
 - (c) promote and support the teaching and learning of many forms of music, from elementary to advanced levels;
 - (d) foster and facilitate the academic study of musical forms by lectures, publications and all other educational means;
 - (e) actively seek and maintain the status as a charitable organisation with the ability to raise funds and to continue to be financially viable;
 - (f) promote the work of the Conservatorium and otherwise do whatever is necessary or desirable to enhance its reputation and business within the community on the Central Coast region of New South Wales and beyond; and
 - (g) do all other things as may be incidental or conducive to the attainment of all or any of these objects.

And for the avoidance of doubt and for the purpose of section 150(1)(a) of the Corporations Act, it is confirmed that this Constitution requires the Company to pursue charitable purposes only and to apply its income in promoting those purposes.

- 4.2 The Company may only exercise the powers in section 124(1) of the Corporations Act to:
- (a) carry out the Objects in this clause; and
 - (b) do all things incidental or convenient in relation to the exercise of power under clause 4.2(a).

Income and property of Company

5. Income and property of Company

- 5.1 Subject to clause 5.2 and 48, to avoid doubt and for the purpose of section 150(1)(a) of the Corporations Act, the income and property of the Company will be used and applied solely towards promoting the Objects of the Company set out in clause 4.1 and no portion will be distributed, paid or transferred (whether directly or indirectly and whether by way of fee, dividend, bonus or profit) to a Member or Director of the Company.
- 5.2 Nothing in clause 5.1 prevents the Company from making good faith payments to a Member or Director as genuine compensation for services provided to, or reasonable expenses incurred on behalf of, the Company, or such other payments, distributions or transfers as may be permitted by the Applicable Not-for-Profit Laws.

Gift Fund

6. Establishment of the Gift Fund

- 6.1 While the Company is endorsed as a deductible gift recipient under Subdivision 30-BA of the Tax Act, it shall establish and maintain, for the Objects of the Company, the Gift Fund in accordance with section 30-130(1) of the Tax Act:
- (a) to which all gifts of money or property for the Objects of the Company set out in clause 4.1 are to be made;
 - (b) to which contributions described in item 7 or 8 of the table in section 30-15 of the Tax Act in relation to a fund-raising event held for the Objects of the Company set out in clause 4.1 are to be made;
 - (c) to which any money received by the Company because of such gifts or contributions is to be credited; and
 - (d) that does not receive any other money or property.
- 6.2 For the avoidance of doubt:
- (a) a separate bank account must be opened for the Gift Fund and only those items described in this clause 6.1 must be deposited into that bank account; and
 - (b) any monies deposited in the Gift Fund will be kept separate from all other funds of the Company and will only be used to further the Objects of the Company set out in clause 4.1. The Company must use the Gift Fund only for the Objects of the Company.
- 6.3 Receipts must be issued to donors in relation to gifts to the Gift Fund and must state:
- (a) the full name of the Company;
 - (b) the Australian Business Number (if applicable) of the Company and Australian Company Number of the Company; and
 - (c) the fact that the receipt is for a gift.

7. Not-for-profit

- 7.1 The Gift Fund and Company will be operated on a not-for-profit basis.
- 7.2 The income, property and assets of the Gift Fund and Company shall be used and applied solely in furtherance of the Objects of the Company set out in clause 4.1 and no portion shall be distributed, paid or transferred directly or indirectly by way of dividend, bonus or by way of profit or otherwise to the Members or Directors of the Company except as genuine compensation for services rendered or reimbursement of out-of-pocket expenses incurred on behalf of the Company or as may otherwise be permitted under the Applicable Not for Profit Laws.

Membership

8. Admission

- 8.1 The number of Members with which the Company proposes to be registered is unlimited.
- 8.2 Subject to this Constitution and applicable law (including the Corporations Act), the Directors may from time to time determine, vary and replace:
- (a) the classes of membership of the Company (including the rights attaching, or not attaching, to a particular class of membership) provided that such a determination, variation or replacement will have no effect unless and until it is approved by a resolution

of the Company passed in general meeting by not less than a majority of the Members entitled to vote on the resolution; and

- (b) the qualifications for admission, and continued membership, in a particular class of membership (including any membership fees payable on application or on a periodic basis).

8.3 The Members of the Company are:

- (a) the persons that become Director and Teacher Members on the Adoption Date, in accordance with clause 8.9; and
- (b) any other persons, corporations or organisations who are admitted to membership in accordance with this Constitution,

and whose membership has not ceased pursuant to clause 9.

8.4 The membership of the Company consists of the following classes of Members:

- (a) Director and Teacher Members; and
- (b) Ordinary Members.

8.5 For the avoidance of doubt, all classes of Members referenced in clause 8.4 are entitled to one vote.

8.6 The Directors in their discretion may by resolution transfer a Member from one class of membership to another.

8.7 Any employees, other than Teachers employed to provide teaching services, are not eligible for membership.

8.8 To be eligible for appointment as a Director and Teacher Member, a person must be:

- (a) a Director of the Company; or
- (b) a Teacher.

8.9 Any Teachers engaged by the Company, and Directors holding office, as at the Adoption Date, will automatically become Director and Teacher Members on the Adoption Date and this will be recorded in the Register.

8.10 If a Director or Teacher is an Ordinary Member on the date of their appointment or engagement (as applicable), the Directors will as soon as possible resolve to transfer the person's membership from Ordinary Member to Director and Teacher Member and arrange for the Register to be updated to reflect the change to the class of membership.

8.11 Subject to clause 8.10, as soon as possible following their appointment, the Directors will admit any person appointed as a Director of the Company as a Director and Teacher Member, provided that the relevant Director has:

- (a) consented to become a Member; and
- (b) provided all information required by the Directors in their absolute discretion.

8.12 If a Director is admitted as a Director and Teacher Member in accordance with clause 8.11, the Secretary will as soon as practicable enter, or cause to be entered, the Director's name in the Register (at which point the Director becomes a Member).

8.13 For the avoidance of doubt, subject to clauses 8.9 and 8.10, a person engaged by the Company as a Teacher does not automatically become a Director and Teacher Member, but may apply for admission as a Director and Teacher Member pursuant to clause 8.14.

8.14 Applications for membership of the Company:

- (a) may be made by:

- (i) in the case of Ordinary Membership, any person over the age of 18 years, any corporation or any organisation who or which is interested in pursuing and supporting the Objects of the Company; and
 - (ii) in the case of Director and Teacher Membership, any person that meets the eligibility criteria in clause 8.8; and
- (b) must be in writing, signed by the applicant and provided to the Secretary in a form approved by, and containing the information required by, the Directors in their absolute discretion, and paying any required membership fees.
- 8.15 The Directors will consider an application for membership made in accordance with clause 8.14 at the next Board meeting after the application is duly received. In considering an application for membership the Directors may:
- (a) by resolution accept or reject the application; or
 - (b) ask the applicant to give more evidence of eligibility or suitability for membership.
- 8.16 If the Directors ask for more evidence under clause 8.15 their determination of the application for membership is deferred until the evidence is given.
- 8.17 The Directors do not have to give any reason for rejecting an application for membership under clause 8.15.
- 8.18 As soon as practicable following acceptance of an application for membership by the Directors the Secretary will:
- (a) subject to receipt from the applicant of any required membership fees under clause 8.14(b) enter, or cause to be entered, the applicant's name and class of membership in the Register (whereupon the applicant becomes a Member); and
 - (b) send, or cause to be sent to, the applicant written notice of the acceptance.
- 8.19 The rights and privileges of every Member are personal to each Member and are not transferable by the Member's own act or by operation of law.

9. Membership fees

- 9.1 The Directors may in their discretion set fees payable by Ordinary Members to obtain and / or retain membership.
- 9.2 For the avoidance of doubt, the fees set by Directors under clause 9.1 may be different for different Ordinary Members, including Ordinary Members that are individuals and corporates respectively.
- 9.3 Director and Teacher Members are not required to pay membership fees.

10. Ceasing to be a Member

- 10.1 A Member's membership of the Company will cease:
- (a) if the Member gives the Secretary written notice of resignation, from the date of receipt of that notice by the Secretary unless they are the sole member, in which case from the date another Member is appointed or the Company is wound up;
 - (b) if a majority of the Directors present and voting at a Board meeting by resolution terminate the membership of a Member and:
 - (i) whose conduct, position or circumstances in the opinion of the Directors renders it undesirable that that Member continue to be a Member of the Company; and

- (ii) only after the Member has been given at least 21 days' notice of the proposed resolution and has had the opportunity to be heard at the meeting at which the resolution is proposed;
 - (c) in the case of a Director or Teacher Member, if the Member ceases to be either a Director or Teacher;
 - (d) where the Member is an individual, if the Member:
 - (i) dies;
 - (ii) becomes mentally incapacitated or whose person or estate is liable to be dealt with in any way under the laws relating to mental health;
 - (iii) is convicted of an indictable offence; or
 - (iv) becomes bankrupt;
 - (e) where the Member fails to pay any required membership fees by the applicable due date for payment and such fees remain unpaid for more than 30 days after notification by the Company to the Member; or
 - (f) where the Member has not attended two consecutive general meetings and receives a notice from the Company requesting the Member confirm if they wish to remain a Member, and does not respond to the notice within 21 days of receipt (unless the Directors resolve otherwise).
- 10.2 For the avoidance of doubt, if a person ceases to be a Director or Teacher Member in accordance with clause 10.1(c), the person may apply to be admitted as an Ordinary Member in accordance with clause 8.14.

11. Powers of attorney

- 11.1 If a Member executes or proposes to execute any document or do any act by or through an attorney which affects the Company or the Member's membership in the Company, that Member must deliver the instrument appointing the Attorney to the Company for notation.
- 11.2 If the Company asks the Member to file with it a certified copy of the instrument for the Company to retain, the Member will promptly comply with that request.
- 11.3 The Company may ask for whatever evidence it thinks appropriate that the power of attorney is effective and continues to be in force.

General meetings

12. Calling general meeting

- 12.1 Any Director may, at any time, call a general meeting.
- 12.2 A Member may:
 - (a) only request the Directors to call a general meeting in accordance with section 249D of the Corporations Act; and
 - (b) not request or call and arrange to hold a general meeting except under section 249E or 249F of the Corporations Act.
- 12.3 The Directors must call an annual general meeting to be held each calendar year to the extent required by, and in accordance with, the Corporations Act.

13. Using technology to hold general meetings

- 13.1 Despite anything in this Constitution, the attendees need not all be physically present in the same place for a general meeting to be held in accordance with this Constitution. A general meeting may be held by all attendees communicating with each other by any technological means which gives all Members as a whole a reasonable opportunity to participate in the general meeting. For the avoidance of doubt, the Company can hold a general meeting by:
- (a) all attendees physically attending the meeting at one or more designated locations;
 - (b) using virtual meeting technology that allows all attendees to simultaneously hear each other and participate in discussion; or
 - (c) using a combination of the above methods.
- 13.2 A Director, Member or any other attendee who attends a general meeting held using technological means is taken to be present and is entitled to vote at the meeting (to the extent they are entitled to vote in accordance with this Constitution).
- 13.3 Despite anything in clause 19, the means by which voting will occur will be determined by the Directors, ensuring that all attendees of a meeting held in accordance with this clause 13 have a mechanism for adequate participation.

14. Notice of general meeting

- 14.1 Subject to the provisions of the Corporations Act allowing general meetings to be held with shorter notice, at least 21 days written notice (exclusive of the day on which the notice is served or deemed to be served and of the day for which notice is given) must be given to Members of any general meeting.
- 14.2 A notice calling a general meeting:
- (a) must specify the place, date and time of the meeting and if the meeting is to be held in two or more places or virtually in accordance with clause 13, the technology that will be used to facilitate this;
 - (b) must state the general nature of the business to be transacted at the meeting;
 - (c) must specify a place and may specify an electronic address or other electronic means for the purposes of proxy appointment or proxy appointment authorities;
 - (d) if a special resolution is to be proposed at the meeting, must specify an intention to propose the special resolution and state the resolution; and
 - (e) must comply with the Corporations Act.
- 14.3 A notice of an annual general meeting need not state that the business to be transacted at the meeting includes:
- (a) the consideration of the annual financial report, Directors' report and the Auditor's report;
 - (b) the election of directors; or
 - (c) the appointment and fixing of the remuneration of the Auditor.
- 14.4 The Directors may postpone or cancel any general meeting whenever they think fit (other than a meeting called as the result of a request under clause 12.2).
- 14.5 The Directors must give notice of the postponement or cancellation of a general meeting to all persons referred to in clause 55.1 entitled to receive notices from the Company.
- 14.6 The failure or accidental omission to send a notice of a general meeting (including a proxy appointment form) to any Member or the non-receipt of a notice (or form) by any Member does not invalidate the proceedings at or any resolution passed at the general meeting.

Proceedings at general meetings

15. Member

In clauses 16, 17, 19 and 22, Member includes a Member present in person or by proxy, attorney or Representative.

16. Quorum

- 16.1 No business may be transacted at a general meeting unless a quorum of Members is present when the meeting proceeds to business.
- 16.2 A quorum of Members is a majority of Members unless the Company has only one Member, in which case a quorum is that Member.
- 16.3 If a quorum is not present within 30 minutes after the time appointed for a general meeting:
- (a) if the general meeting was called on the requisition of Members, it is automatically dissolved; or
 - (b) in any other case:
 - (i) it will stand adjourned to the same time and place seven days after the meeting, or to another day, time and place determined by the Directors; and
 - (ii) if at the adjourned general meeting a quorum is not present within 30 minutes after the time appointed for the general meeting, the general meeting is automatically dissolved.

17. Chairperson

- 17.1 The chairperson, or in the chairperson's absence the deputy chairperson, of Directors' meetings will be the chairperson at every general meeting.
- 17.2 The Directors present may elect a chairperson of a general meeting if:
- (a) there is no chairperson or deputy chairperson; or
 - (b) neither the chairperson nor deputy chairperson is present within 15 minutes after the time appointed for holding the general meeting; or
 - (c) the chairperson and deputy chairperson are unwilling to act as chairperson of the general meeting.
- 17.3 If no election is made under clause 17.2, then:
- (a) the Members may elect one of the Directors present as chairperson; or
 - (b) if no Director is present or is willing to take the chair, the Members may elect one of the Members present as chairperson.
- 17.4 If there is a dispute at a general meeting about a question of procedure, the chairperson may determine the question.
- 17.5 The chairperson of an annual general meeting must allow a reasonable opportunity for the Members as a whole at the meeting to ask questions about or make comments on the management of the Company.

18. Adjournment

- 18.1 The chairperson of a general meeting at which a quorum is present:

- (a) in his or her discretion may adjourn the general meeting with the meeting's consent; and
 - (b) must adjourn the general meeting if the meeting directs him or her to do so.
- 18.2 An adjourned general meeting may take place at a different venue to the initial general meeting (or in the case of a general meeting held virtually or in two or more places in accordance with clause 13, using different virtual meeting technology).
- 18.3 The only business that can be transacted at an adjourned general meeting is the unfinished business of the initial general meeting.
- 18.4 Notice of an adjourned general meeting must only be given in accordance with clause 14.1 if a general meeting has been adjourned for more than 21 days.

19. Decision on questions

- 19.1 Subject to the Corporations Act and this Constitution (including clauses 64 and 65) in relation to special resolutions, a resolution is carried if a majority of the votes cast on the resolution are in favour of the resolution.
- 19.2 A resolution put to the vote of a meeting is decided on a show of hands unless a poll is demanded in accordance with the Corporations Act.
- 19.3 Unless a poll is demanded:
- (a) a declaration by the chairperson that a resolution has been carried, carried by a specified majority, or lost; and
 - (b) an entry to that effect in the minutes of the meeting,
- are conclusive evidence of the fact without proof of the number or proportion of the votes in favour of or against the resolution.
- 19.4 The demand for a poll may be withdrawn.
- 19.5 A decision of a general meeting may not be impeached or invalidated on the ground that a person voting at the general meeting was not entitled to do so.

20. Taking a poll

- 20.1 A poll will be taken when and in the manner that the chairperson directs.
- 20.2 The result of the poll will be the resolution of the meeting at which the poll was demanded.
- 20.3 The chairperson may determine any dispute about the admission or rejection of a vote.
- 20.4 The chairperson's determination, if made in good faith, will be final and conclusive.
- 20.5 A poll demanded on the election of the chairperson or the adjournment of a general meeting must be taken immediately.
- 20.6 After a poll has been demanded at a general meeting, the general meeting may continue for the transaction of business other than the question on which the poll was demanded.

21. Casting vote of chairperson

The chairperson does not have a casting vote in addition to the chairperson's votes as a Member, proxy, attorney or Representative.

Votes of Members

22. Entitlement to vote

22.1 A Member entitled to vote has one vote (on a poll or show of hands).

23. Objections

23.1 An objection to the qualification of a voter may only be raised at the general meeting or adjourned general meeting at which the voter tendered its vote.

23.2 An objection must be referred to the chairperson of the general meeting, whose decision made in good faith is final.

23.3 A vote which the chairperson does not disallow because of an objection is valid for all purposes.

24. Votes by proxy

24.1 If a Member appoints a proxy, proxies or an attorney, the proxy, proxies or attorney may, subject to the Corporations Act, vote on a show of hands.

24.2 A proxy need not be a Member.

24.3 A proxy may demand or join in demanding a poll.

24.4 A proxy or attorney may vote on a poll.

24.5 A proxy may vote or abstain as he or she chooses except where the appointment of the proxy directs the way the proxy is to vote on a particular resolution. If an appointment directs the way the proxy is to vote on a particular resolution:

- (a) the proxy need not vote on a show of hands, but if the proxy does so, the proxy must vote that way;
- (b) if the proxy has two or more appointments that specify different ways to vote on the resolution - the proxy must not vote on a show of hands;
- (c) if the proxy is the chair - the proxy must vote on a poll, and must vote that way; and
- (d) if the proxy is not the chair - the proxy need not vote on a poll, but if the proxy does so, the proxy must vote that way.

25. Document appointing proxy

25.1 An appointment of a proxy is valid if it is signed, or authenticated in accordance with the Corporations Act, by the Member making the appointment and contains the information required by subsection 250A(1) of the Corporations Act. The Directors may determine that an appointment of a proxy is valid even if it only contains some of the information required by section 250A(1) of the Corporations Act.

25.2 The Company may send a proxy appointment form to Members in a form which has been approved by the Directors.

25.3 A proxy's appointment is valid at an adjourned general meeting.

25.4 A proxy or attorney may be appointed for all general meetings or for any number of general meetings or for a particular purpose.

- 25.5 Unless otherwise provided for in the proxy's appointment or in any instrument appointing an attorney, the appointment of the proxy or the attorney will be taken to confer authority:
- (a) to vote on:
 - (i) any amendment moved to the proposed resolutions and on any motion that the proposed resolutions not be put or any similar motion; and
 - (ii) any procedural motion, including any motion to elect the chairperson, to vacate the chair or to adjourn the general meeting,
 even though the appointment may specify the way the proxy or attorney is to vote on a particular resolution; and
 - (b) to vote on any motion before the general meeting whether or not the motion is referred to in the appointment.
- 25.6 If a proxy appointment is signed or authenticated by the Member but does not name the proxy or proxies in whose favour it is given, the chairperson may either act as proxy or complete the proxy appointment by inserting the name or names of one or more Directors or the Secretary.

26. Lodgement of proxy

- 26.1 Subject to clause 25.3, the appointment of a proxy or attorney must be received by the Company, at least 48 hours (unless reduced in the notice of meeting to which the appointment relates) before the general meeting (or the resumption of an adjourned general meeting) at which the appointee is to attend and vote.
- 26.2 If the appointment purports to be executed under a power of attorney or other authority, the original document or a certified copy of it must be received by the Company at least 48 hours (unless reduced in the notice of meeting to which the appointment relates) before the general meeting (or the resumption of an adjourned general meeting).
- 26.3 The Company receives an appointment of a proxy or attorney or other authority under which it was signed when they are:
- (a) received at:
 - (i) the Company's registered office;
 - (ii) a facsimile number at the Company's registered office; or
 - (iii) a place, facsimile number or electronic address specified for that purpose in the notice of general meeting; or
 - (b) if the notice of general meeting specifies other electronic means by which a Member may give an appointment, received by the Company in accordance with the Corporations Act.

27. Validity

A vote cast in accordance with an appointment of proxy or power of attorney is valid even if before the vote was cast the appointor:

- (a) died;
- (b) became mentally incapacitated; or
- (c) revoked the proxy or power,

unless any written notification of the death, unsoundness of mind or revocation was received by the Company before the relevant general meeting or adjourned general meeting.

28. Representatives of bodies corporate

- 28.1 Any Member that is a body corporate may appoint an individual as its representative as provided by the Corporations Act.
- 28.2 The appointment of a Representative may set out restrictions on the Representative's powers.
- 28.3 The original form of appointment of a Representative, a certified copy of the appointment, or a certificate of the body corporate evidencing the appointment of a Representative is prima facie evidence of a Representative having been appointed.
- 28.4 The chairperson of a general meeting may permit a person claiming to be a Representative to exercise the body's powers even if he or she has not produced a certificate or other satisfactory evidence of his or her appointment.

Written resolutions

29. Written resolutions

- 29.1 The Company may pass a resolution without a general meeting being held if all the Members entitled to vote on the resolution sign a document containing a statement that they are in favour of the resolution set out in the document. The resolution is passed when the last Member signs.
- 29.2 For the purposes of clause 29.1, separate copies of a document may be used for signing by Members if the wording is identical in each copy.
- 29.3 If the Company has one Member, the Company may pass a resolution by the Member recording it and signing the record.
- 29.4 Any document referred to in this clause may be in the form of a facsimile or electronic transmission or notification.
- 29.5 Any written resolution passed in accordance with this clause satisfies any requirement in the Constitution or in the Corporations Act (to the extent permitted by the Corporations Act) that the resolution be passed at a general meeting (or be a special resolution).

Appointment and removal of Directors

30. Number of Directors

- 30.1 There will not be less than three and no more than nine Directors, unless the Company by resolution passed in general meeting (by Members entitled to vote under clause 22) changes the maximum number.
- 30.2 A minimum of two of the Directors must be Australian residents.
- 30.3 The initial Directors of the Company are the persons who have consented to act as directors and are set out in the Company's application for registration as a Company. Those persons hold office subject to this Constitution.

31. Qualification

- 31.1 A Director needs to:

- (a) as soon as possible following their appointment as a Director, be admitted as and remain a Member;
- (b) be an Australian resident; and
- (c) not be a current employee (whether full-time or part-time) of the Company or of any related body corporate of the Company.

32. Appointment and removal of Directors

- 32.1 Subject to clause 30, the Company may by resolution passed in general meeting by Members entitled to vote under clause 22:
- (a) appoint new Directors;
 - (b) increase or reduce the number of Directors;
 - (c) remove any Director; and
 - (d) appoint another person in the Director's place.

33. Suspension of Directors

- 33.1 If the conduct, position or circumstances of any Director is such that continuance in office appears to the majority of the Directors to be prejudicial to the interests of the Company, a majority of Directors at a meeting of the Directors specifically called for that purpose may suspend that Director.
- 33.2 Within 14 days of any suspension under clause 33.1, the Directors must call a general meeting, at which the Members entitled to vote under clause 22 may either confirm the suspension and remove the Director from office in accordance with clause 32.1(c) or annul the suspension and reinstate the Director.

34. Additional and casual Directors

- 34.1 Subject to clause 30 the Directors may appoint any person as a Director to fill a casual vacancy or as an addition to the existing Directors.
- 34.2 A Director appointed in accordance with clause 34.1 will hold office until the Company's next general meeting, and at which point the Director can stand for election as set out in clause 32.

35. Period of office

- 35.1 A Director must retire from office at the commencement of the third annual general meeting after the Director was last elected or appointed.
- 35.2 Subject to clause 35.3, a retiring Director is eligible for re-election or re-appointment for further terms of three years by a resolution passed at the annual general meeting, which re-appointment will take effect from the time they are re-elected or re-appointed at that meeting.
- 35.3 Any person who has been a Director for nine years cumulatively is not eligible for re-election or re-appointment under clause 35.2.
- 35.4 If a retiring Director is ineligible for re-election or re-appointment solely because of clause 35.3 and two thirds of the elected Directors determine that the retiring Director should be eligible for a further and final term of one year, clause 35.3 is deemed not to apply to that Director and they are eligible for re-election or re-appointment in accordance with clause 35.2 for a further and final term of one year.

36. Retirement of Initial Directors

36.1 One third (to the nearest whole number) of the initial Directors (appointed in accordance with clause 30.3) being the:

- (a) longest serving initial Directors as at the date of transition to a company limited by guarantee, will retire from office at the commencement of the first annual general meeting after the Company became a company limited by guarantee and will be eligible for re-election or re-appointment in accordance with clause 35.2;
- (b) second longest serving initial Directors as at the date of transition to a company limited by guarantee, will retire from office at the commencement of the second annual general meeting after the Company became a company limited by guarantee and will be eligible for re-election or re-appointment in accordance with clause 35.2; and
- (c) initial Directors who have served the least years as at the date of transition to a company limited by guarantee, will retire from office at the commencement of the third annual general meeting after the Company became a company limited by guarantee and will be eligible for re-election or re-appointment in accordance with clause 35.2.

37. Vacation of office

The office of a Director immediately becomes vacant if the Director:

- (a) is prohibited by the Corporations Act or the ACNC Act (while the Company is a Registered Entity) from holding office or continuing as a Director;
- (b) in the opinion of the Directors, is incapable of managing their affairs due to mental or physical incapacity, or becomes, in the opinion of the Directors, incapable of performing his or her duties;
- (c) is committed of an indictable offence;
- (d) resigns by notice in writing to the Company, from the date of receipt of that notice by the Secretary, or on a later date specified in the notice;
- (e) becomes bankrupt or makes any general arrangement or composition with his or her creditors;
- (f) is removed by a resolution of the Company pursuant to clause 32.1(c);
- (g) is absent from Directors' meetings for three consecutive months without leave of absence from the Directors;
- (h) is directly or indirectly interested in any contract or proposed contract with the Company and fails to declare the nature of the interest as required by the Corporations Act;
- (i) ceases to meet the qualification requirements in clause 31;
- (j) becomes of unsound mind or a person whose estate is liable to be dealt with in any way under a law relating to mental health; or
- (k) dies.

Powers and duties of Directors

38. Powers and duties of Directors

38.1 The business of the Company is managed by the Directors who may exercise all powers of the Company that this Constitution and the Corporations Act do not require to be exercised by the Company in general meeting.

38.2 Without limiting the generality of clause 38.1, the Directors may exercise all the powers of the Company to:

- (a) borrow money;
- (b) charge any property or business of the Company;
- (c) issue debentures or give any other security for a debt, liability or obligation of the Company or of any other person; and
- (d) guarantee or to become liable for the payment of money or the performance of any obligation by or of any other person.

39. Delegation

- 39.1 The Directors may delegate any of their powers, other than those which by law must be dealt with by the Directors as a board, to:
- (a) a committee of Directors (which may include persons other than Directors in addition to at least one Director);
 - (b) a Director;
 - (c) an employee of the Company; or
 - (d) any other person.
- 39.2 A committee or person to which any powers have been delegated must exercise its powers in accordance with any directions of the Directors and a power exercised in that way is taken to have been exercised by the Directors.
- 39.3 A committee or person to which any powers have been delegated may be authorised to sub-delegate all or any of the powers for the time being vested in it.
- 39.4 The Directors may at any time revoke any delegation of power.
- 39.5 Meetings of any committee will be governed by the provisions of this Constitution which deal with Directors' meetings so far as they are applicable and are not inconsistent with any directions of the Directors.

Proceedings of Directors

40. Directors' meetings

- 40.1 A Director may at any time, and the Secretary must on the request of a Director, call a Directors' meeting.
- 40.2 A Directors' meeting must be called by giving not less than 48 hours' notice of a meeting to each Director, unless the Directors unanimously agree otherwise. The notice may be in writing or given using any technology consented to by all the Directors.
- 40.3 An accidental omission to send a notice of a meeting of Directors to any Director or the non-receipt of such a notice by any Director does not invalidate the proceedings, or any resolution passed, at the meeting.
- 40.4 Subject to the Corporations Act, a Directors' meeting may be held by the Directors communicating with each other by any technological means by which they are able simultaneously to hear each other and to participate in discussion.
- 40.5 The Directors need not all be physically present in the same place for a Directors' meeting to be held.

- 40.6 Subject to clause 49, a Director who participates in a meeting held in accordance with this Constitution is taken to be present and entitled to vote at the meeting.
- 40.7 Clauses 40.4 to 40.6 apply to meetings of Directors' committees as if all committee members were Directors.
- 40.8 The Directors may meet together, adjourn and regulate their meetings as they think fit.
- 40.9 Where the Company has five or more Directors, a quorum is five Directors. Where the Company has less than five Directors, a quorum is three Directors. The quorum must be present at all times during the meeting.
- 40.10 Where a quorum cannot be established for the consideration of a particular matter at a meeting of Directors, the chairperson may call a general meeting to deal with the matter.

41. Decision on questions

- 41.1 Subject to this Constitution, questions arising at a meeting of Directors are to be decided by a majority of votes of the Directors present and voting.
- 41.2 Subject to clause 49 and the Corporations Act, each Director has one vote.
- 41.3 If there is an equality of votes, the chairperson of a meeting does not have a casting vote in addition to his or her deliberative vote.
- 41.4 An Alternate Director has one vote for each Director for whom he or she is an alternate.
- 41.5 If the Alternate Director is a Director, he or she also has a vote as a Director.

42. Alternate Directors

- 42.1 A Director may, with the approval of a majority of the other Directors, appoint any person as his or her alternate for a period determined by that Director.
- 42.2 An Alternate Director is entitled to notice of Directors' meetings and, if the appointor is not present at a meeting, is entitled to attend, be counted in a quorum and vote as a Director.
- 42.3 An Alternate Director is an officer of the Company and is not an agent of the appointor.
- 42.4 The provisions of this Constitution which apply to Directors also apply to Alternate Directors.
- 42.5 The appointment of an Alternate Director:
- (a) may be revoked at any time by the appointor or the other Directors; and
 - (b) end automatically when the appointor ceases to be a Director.
- 42.6 Any appointment or revocation under this clause must be effected by written notice delivered to the Secretary.

43. Remaining Directors

- 43.1 The Directors may act even if there are vacancies on the board.
- 43.2 If the number of Directors is not sufficient to constitute a quorum at a Directors' meeting, the Directors may act only to:
- (a) appoint a Director; or

- (b) call a general meeting.

44. Chairperson

- 44.1 The Directors may elect a Director as chairperson of Directors' meetings and may determine the period for which the chairperson will hold office.
- 44.2 If no chairperson is elected or if the chairperson is not present at any Directors' meeting within ten minutes after the time appointed for the meeting to begin, the Directors present must elect a Director to be chairperson of the meeting.
- 44.3 The Directors may elect a Director as deputy chairperson to act as chairperson in the chairperson's absence.

45. Written resolutions

- 45.1 The Directors may pass a resolution without a Directors' meeting being held if all the Directors entitled to vote on the resolution sign a document containing a statement that they are in favour of the resolution set out in the document. The resolution is passed when the last Director entitled to vote signs.
- 45.2 For the purposes of clause 45.1, separate copies of a document may be used for signing by Directors if the wording of the resolution and statement is identical in each copy.
- 45.3 Any document referred to in this clause may be in the form of a facsimile or electronic transmission or notification.
- 45.4 The minutes of Directors' meetings must record that a resolution was passed in accordance with this clause.
- 45.5 This clause applies to meetings and resolutions of Directors' committees as if all members of the committee were Directors.

46. Validity of acts of Directors

If it is discovered that:

- (a) there was a defect in the appointment of a person as a Director, Alternate Director or member of a Directors' committee; or
- (b) a person appointed to one of those positions was disqualified,

all acts of the Directors or the Directors' committee before the discovery was made are as valid as if the person had been duly appointed and was not disqualified.

47. Minutes and Registers

- 47.1 The Directors must cause minutes to be made of:
- (a) the names of the Directors present at all general meetings, Directors' meetings and meetings of Directors' committees;
- (b) all proceedings and resolutions of general meetings, Directors' meetings and meetings of Directors' committees;
- (c) all resolutions passed by Members in accordance with clause 29 or the Corporations Act;
- (d) all resolutions passed by Directors in accordance with clause 45;
- (e) all appointments of officers;

- (f) all orders made by the Directors and Directors' committees; and
 - (g) all disclosures of interests made under clause 49.
- 47.2 Minutes must be signed by the chairperson of the meeting or by the chairperson of the next meeting of the relevant body, and if so signed will as between the Directors be conclusive evidence of the matters stated in such minutes.
- 47.3 The Company must keep all registers required by this Constitution and the Corporations Act.

Payments to Directors and Directors interests

48. Payments to Directors

No payment will be made to any Director other than payment:

- (a) of out of pocket expenses reasonably and properly incurred by the Director in the performance of any duty as Director, provided that such amount has the prior approval of the Directors;
- (b) for any service rendered to the Company by the Director in a professional or technical capacity, other than in the capacity as Director, where the provision of the service, and the amount payable, has the prior approval of the Directors and is not more than an amount which commercially would be reasonable payment for the service; and
- (c) relating to an indemnity in favour of the Director and permitted by section 199A of the Corporations Act or a contract of insurance permitted by section 199B of the Corporations Act.

49. Directors' interests

- 49.1 As required by the Corporations Act, a Director must give the Directors notice of any material personal interest in a matter that relates to the affairs of the Company.
- 49.2 Subject to the provisions of this clause 49, a Director or a body or entity in which a Director has a direct or indirect interest may:
- (a) enter into any agreement or arrangement with the Company;
 - (b) hold any office or place of profit other than as auditor in the Company; and
 - (c) act in a professional capacity other than as auditor for the Company,
- and the Director or the body or entity can receive and keep beneficially any remuneration, profits or benefits under any agreement or arrangement with the Company or from holding an office or place of profit in or acting in a professional capacity with the Company.
- 49.3 The fact that a Director holds office as a director, and has fiduciary obligations arising out of that office:
- (a) will not void or render voidable a contract made by a Director with the Company;
 - (b) will not void or render voidable a contract or arrangement entered into by or on behalf of the Company and in which the Director may have any interest; and
 - (c) will not require the Director to account to the Company for any profit realised by or under any contract or arrangement entered into by or on behalf of the Company and in which the Director may have any interest.
- 49.4 A Director may be or become a director or other officer of, or otherwise be interested in:
- (a) any related body corporate of the Company; or
 - (b) any other body corporate promoted by the Company or in which the Company may be interested as a vendor, shareholder or otherwise,

and is not accountable to the Company for any remuneration or other benefits received by the Director as a director or officer of, or from having an interest in, that body corporate.

- 49.5 A Director who has a material personal interest in a matter that is being considered at a Directors' meeting must not:
- (a) be present while the matter is being considered at the meeting; or
 - (b) vote on the matter,
- unless permitted to do so by the Corporations Act, in which case the Director may:
- (c) be counted in determining whether or not a quorum is present at any meeting of Directors considering that contract or arrangement or a proposed contract or arrangement;
 - (d) sign or countersign any document relating to that contract or arrangement or a proposed contract or arrangement; and
 - (e) vote in respect of, or in respect of any matter arising out of, the contract or arrangement or proposed contract or arrangement.

50. Conflicts of interest

In addition to clause 49.5, the Directors shall, to the extent required by any applicable law, establish a mechanism for dealing with any conflicts of interest that may occur involving a Director, officer or employee of the Company.

51. Appointment of attorneys and agents

- 51.1 The Directors may from time to time by resolution or power of attorney executed in accordance with section 127 of the Corporations Act appoint any person to be the attorney or agent of the Company:
- (a) for the purposes;
 - (b) with the powers, authorities and discretions (not exceeding those exercisable by the Directors under this Constitution);
 - (c) for the period; and
 - (d) subject to the conditions,
- determined by the Directors.
- 51.2 An appointment by the Directors of an attorney or agent of the Company may be made in favour of:
- (a) any member of any local board established under this Constitution;
 - (b) any company;
 - (c) the members, directors, nominees or managers of any company or firm; or
 - (d) any fluctuating body of persons whether nominated directly or indirectly by the Directors.
- 51.3 A power of attorney may contain such provisions for the protection and convenience of persons dealing with an attorney as the Directors think fit.
- 51.4 The Directors may appoint attorneys or agents by electronic, facsimile or telegraphic transmission to act for and on behalf of the Company.
- 51.5 An attorney or agent appointed under this clause may be authorised by the Directors to sub-delegate all or any of the powers authorities and discretions for the time being vested in it.

Secretary

52. Secretary

- 52.1 Unless not required by the Corporations Act, there must be at least one secretary of the Company who ordinarily resides in Australia appointed by the Directors on conditions determined by them.
- 52.2 The Secretary is entitled to attend and be heard on any matter at all Directors' and general meetings.
- 52.3 The Directors may, subject to the terms of the Secretary's employment contract (if any), suspend, remove or dismiss the Secretary.

Inspection of records

53. Inspection of records

- 53.1 Except as otherwise required by the Corporations Act, the Directors may determine whether and to what extent, and at what times and places and under what conditions, the financial records and other documents of the Company or any of them will be open for inspection by Members other than Directors.
- 53.2 Subject to clause 53.3 and except as otherwise required by the Corporations Act, a Member other than a Director does not have the right to inspect any financial records or other documents of the Company unless the Member is authorised to do so by a court order or a resolution of the Directors.
- 53.3 The Secretary, or other Company officer as determined by the Directors, must keep a members' register which any Member may by writing to the Secretary, request to inspect, but such request must not be more than two times a year. In complying with a Member request, the Secretary or other Company officer with responsibility must make the members' register open for inspection within a reasonable timeframe, but no later than 7 days from the date of the request, and may determine at what times and places and under what conditions the register is viewed.

Notices

54. Service of notices

- 54.1 Notice may be given by the Company to any person who is entitled to notice under this Constitution:
- (a) by serving it on the person; or
 - (b) by sending it by post, facsimile transmission or electronic notification (or email) to the person at the person's address shown in the Register or the address supplied by the person to the Company for sending notices to the person; or
 - (c) if it is a notice of meeting, by giving it in accordance with section 249J(3) of the Corporations Act.
- 54.2 A notice sent by post is taken to be served:
- (a) by properly addressing, prepaying and posting a letter containing the notice; and
 - (b) on the day after the day on which it was posted.

- 54.3 Subject to the Corporations Act, a notice sent by facsimile transmission or electronic notification is taken to be served:
- (a) by properly addressing the facsimile transmission or electronic notification and transmitting it; and
 - (b) on the day after its despatch.
- 54.4 If a Member does not have an address recorded in the Register a notice will be taken to be served on that Member 24 hours after it was posted:
- (a) on a notice board at the Company's registered office; or
 - (b) on the Company's website.
- 54.5 A Member whose address recorded in the Register is not in Australia may specify in writing an address in Australia to be taken to be the Member's for the purposes of clause 54.
- 54.6 A certificate in writing signed by a Director, Secretary or other officer of the Company that a document or its envelope or wrapper was addressed and stamped and was posted is conclusive evidence of posting.
- 54.7 Subject to the Corporations Act the signature to a written notice given by the Company may be written or printed.
- 54.8 All notices sent by post outside Australia must be sent by prepaid airmail post.

55. Persons entitled to notice

- 55.1 Notice of every general meeting must be given to:
- (a) every Member who is entitled to attend the general meeting;
 - (b) every Director and Alternate Director; and
 - (c) any Auditor.
- 55.2 No other person is entitled to receive notice of a general meeting.

Seals

56. Common Seal

If the Company has a Seal:

- (a) the Directors must provide for the safe custody of the Seal;
- (b) the Seal must not be used without the authority of the Directors or a Directors' committee authorised to use the Seal; and
- (c) every document to which the Seal is affixed must be signed by a Director and be countersigned by another Director, the Secretary or another person appointed by the Directors to countersign the document.

57. Duplicate Seal

If the Company has a Seal, the Company may have one or more duplicate seals of the Seal each of which:

- (a) must be a facsimile of the Seal with 'Duplicate Seal' on its face; and
- (b) must not be used except with the authority of the Directors.

Audit and accounts

58. Audit and accounts

- 58.1 The Directors must cause the Company to keep written financial records in relation to the business of the Company, and to prepare financial documents and reports, in accordance with the requirements of the Corporations Act and any other applicable laws.
- 58.2 The Directors must cause the financial records and financial documents of the Company to be audited to the extent required by, and in accordance with the requirements of, the Corporations Act and any other applicable laws.

Winding up and revocation of endorsement

59. Winding up

- 59.1 If the Company is wound up:
- (a) each Member; and
 - (b) each person who has ceased to be a Member in the preceding 12 months, undertakes to contribute to the property of the Company for the:
 - (i) payment of debts and liabilities of the Company (in relation to clause 59.1(b), contracted before the person ceased to be a Member) and payment of costs, charges and expenses of winding up; and
 - (ii) adjustment of the rights of the contributories amongst themselves,
 such amount as may be required, not exceeding \$20.00 (and otherwise has no liability for the payment of debts and liabilities of the Company nor obligation to contribute to the property of the Company).
- 59.2 If the Company is endorsed as a deductible gift recipient under Subdivision 30-BA of the Tax Act then on the earlier of the winding up or revocation of endorsement of the Company any surplus of the Gift Fund will, as required by section 30-125 of the Tax Act, be given or transferred to a fund, authority or institution, gifts to which are deductible under Division 30 of the Tax Act and which, by its constitution, is:
- (a) required to pursue charitable purposes only (being charitable purposes similar, as far as possible, to the Objects of the Company);
 - (b) required to apply its profits (if any) or other income in promoting its charitable purpose; and
 - (c) prohibited from making any distribution to its members or paying fees to its directors, to at least the same extent of such prohibitions under this Constitution,
- such fund, authority or institution to be determined by the Members at or before the winding up or revocation and in default, by application to the Supreme Court of New South Wales for determination.
- 59.3 Subject to clause 59.2, on the winding up of the Company, any surplus remaining following the satisfaction of all debts and liabilities of the Company will not be paid to or distributed amongst Members, but will, unless otherwise required by law, be given or transferred to another corporation or body which, by its constitution, is:
- (a) required to pursue charitable purposes only (being charitable purposes similar, as far as possible, to those of the Company);
 - (b) required to apply its income in promoting its charitable purposes; and

- (c) prohibited from making any distribution to its members and paying fees to its directors, to at least the same extent of such prohibitions under this Constitution,

such corporation or body to be determined by the Members, and in default, by application to the Supreme Court of New South Wales for determination.

60. Indemnity

- 60.1 To the extent permitted by law and subject to the restrictions in section 199A of the Corporations Act, the Company indemnifies every person who is or has been an officer of the Company against:
- (a) any liability (other than for legal costs) incurred by that person as an officer of the Company (including liabilities incurred by the officer as an officer of a subsidiary of the Company where the Company requested the officer to accept that appointment); or
 - (b) reasonable legal costs incurred in defending an action for a liability incurred by that person as an officer of the Company (including legal costs incurred by the officer as an officer of a subsidiary of the Company where the Company requested the officer to accept that appointment).
- 60.2 The amount of any indemnity payable under clauses 60.1(a) or 60.1(b) will include an additional amount (GST Amount) equal to any GST payable by the officer being indemnified (Indemnified Officer) in connection with the indemnity (less the amount of input tax credit claimable by the Indemnified Officer in connection with the indemnity). Payment of any indemnity which includes a GST Amount is conditional upon the Indemnified Officer providing the Company with a GST tax invoice for the GST Amount.
- 60.3 For the purposes of this clause and clause 61, officer means:
- (a) a Director; or
 - (b) a Secretary.

61. Insurance

The Company may pay a premium in respect of a contract insuring a person who is or has been an officer against liability incurred by the person as an officer, except in circumstances prohibited by the Corporations Act.

Internal disputes

62. Resolution of internal disputes

- 62.1 Disputes between Members (in their capacity as Members), and disputes between Members and the Company that the parties have not been able to themselves resolve (after following any internal dispute procedures the Directors may specify or adopt) are to be referred to such mediator as the Directors may, subject to applicable law, determine.
- 62.2 At least seven days before such a mediation session is to commence, the parties are to exchange statements of the issues that are in dispute between them and supply copies to the mediator.
- 62.3 Any internal dispute procedures the Directors may specify or adopt may include, without limitation:
- (a) the appointment of an independent person to arbitrate on the dispute;
 - (b) processes to bring the parties together to help resolve the dispute at an early stage, and should allow all parties a full and fair opportunity to present their case.

Complaints

63. Complaints

If, and to the extent, required by any applicable law, the Directors shall ensure that a mechanism is established that will properly and effectively deal with complaints made by members of the public and grievances from employees.

Amendment

64. Amendment of this Constitution

This Constitution may be amended in accordance with the requirements of the Corporations Act.

Execution of documents

65. Execution of documents

The Company may execute a document:

- (a) in accordance with section 127(1) of the Corporations Act;
- (b) if the Company has a Seal, in accordance with section 127(2) of the Corporations Act and clauses 56 and 57; or
- (c) in any other way approved by the Directors and permitted by law.

Applicable Not-for-Profit Laws

66. Applicable Not-for-Profit Laws

The Company will at all times comply with the Applicable Not-for-Profit Laws.
